Lawton Christian School is a member school of OPSAC. The purpose of the Oklahoma Private School Accrediting Commission is to assist the State Board of Education by assuring the educational quality and compliance with applicable rules of the Board by recognized, accredited private schools in the state.

Our goal at LCS is to continue to serve students with special needs in the 3rd through 12th grades, and to be able to take part in the Lindsey Nicole Scholarship. For many years we have worked with Child Find to help LCS students who have special needs receive a quality education. - Will be academically accountable to the parent/legal guardian for meeting the educational needs of the student;
- Employs or contracts with teachers who hold baccalaureate or higher degrees, or have at least three (3) years of teaching experience in public or private schools, or have special skills, knowledge, or expertise that qualifies them to provide instruction in subjects taught;
- Complies with all state laws relating to general regulation of private schools; and
- Adheres to the tenet of its published disciplinary procedures prior to the expulsion of a scholarship student.
